**NOTIFICATION**

**No. A.11013/5/2021 - SERI :** On the recommendation of the Selection Committee for appointment by deputation under Sericulture Department held on 14.7.2022 and in the interest of public service, the Governor of Mizoram is pleased to appoint Dr.Lalthlamuana Pachuau Scientist D (Emp No. 5655), SSPC, Jorhat under Central Silk Board (CSB) to the post of Sericulture Scientist, Sericulture Department, Government of Mizoram in level - 12 of the Pay Matrix on deputation with effect from the date of joining till 31<sup>st</sup> October, 2024 (which is the validity of the post of Sericulture Scientist created vide No. A.11013/5/2021-SERI dated 1.11.2021) with the following terms and conditions :-

1. The Officer shall exercise an option to draw either his pay at the Level in the Pay Matrix of the deputation post or his own Pay in the Pay Matrix in his parent Cadre, but both without deputation duty allowance.
2. An officer who exercised an option to draw the higher Level in the Pay Matrix of the deputation post shall have no right to claim the Pay of the deputation post upon his repatriation after completion of the deputation tenure.
3. Unless the concerned official is in receipt of his salary directly from the Government Accounts of the Consolidated Fund of India, Leave Salary and pension contribution shall be credited regularly by the borrowing authority i.e Sericulture Department to the lending authority i.e Silkworm Production Centre, Central Silk Board, Jorhat.


